# CNW MAILMAN EXPRESS SPRINT TIME TRIAL 2024

#### HORSE OWNER'S TERMS AND CONDITIONS OF PARTICIPATION

- 1. I understand that entry is refused to any thoroughbred horse that has trialled and raced in any country. I understand that the MAILMAN EXPRESS SPRINT TIME TRIAL is an event for non-thoroughbred horses and thoroughbred horses that meet the eligibility criteria outlined before. The Mailman Express is to be held under lights at the Mount Isa Race Course on August 8<sup>th</sup> 2024. Each horse will sprint over approximately 200 metres individually and will be electronically timed. The ten horses which record the fastest times will complete another run with the horse recording the fastest time from these ten sprints to be declared the winner (subject to swabbing, eligibility verification, etc). In the event of a tie for first place after the final, the horses involved will be required to participate in a run-off. If a horse does not take its place in the run-off, it will forfeit first place. There may be betting on the whole event and a "Calcutta" will be held on the final ten horses before the final sprints.
- 2. I acknowledge that participation involves the real risk of injury, possibility serious injury, even death to horse and/or rider. Death and/or injuries may result from circumstances related to, or resulting from, pre-existing disabilities or medical conditions.
- 3. I accept that the Mailman Express field will be capped at the discretion of the Committee, and the fastest ten will time trial in the final.
- 4. I agree to pay the nomination fee of \$75.00 (non-refundable) per horse. (Payment is required at time of nomination).
- 5. I understand that any prizemoney I may win will be paid within 10 working days by EFT after the receipt of a clear swab result into an Australian bank account, details of which will be provided by me to the Organising Committee.
- 6. Riders will be required to wear a protective vest and skullcap on the track. (Riders must provide own vest and skullcap). I understand that riders are NOT permitted to use a jockey or track work pad for this event. I agree that should this horse be included in the final field of ten it will be saddled and be at the starting point before the final commences.
- 7. I accept that neither the Organising Committee nor the Mount Isa Race Club or Racing Queensland accepts liability for any accident, damage, injury or illness to horses, owners, riders, ground spectators or any other person or property whatsoever.
- 8. I agree that riders will be breathalysed for alcohol before the time trial and may also be asked to undergo a drug test, and I understand that a rider will be barred if a positive reading to alcohol and/or drugs is returned.
- 9. I understand that "Local Horse" means horse and owner must reside within a 300 km radius of Mount Isa. Proof of residence required.
- 10. I agree that the rider of my horse will carry a flag in the parade if asked to do so. I agree that if my horse is one of the ten finalists, I will allow it to be swabbed by the appointed veterinarian.
- 11. I understand that riders are to be declared at the Mount Isa Race Club Secretary's Office by **6 pm Monday 5th August 2024** by completion of the Rider's Details Form. I accept that no person who is a **licensed** jockey or jockey apprentice or trainer with any Thoroughbred Racing Body is permitted to ride in the Mailman Express. Minimum age of rider is 16 years (Parent or Guardian of rider under 18 years will be required to sign Rider's Agreement).
- 12. If the competing horse's owner is under 18 years, their Parent or Guardian is required to sign this Owner's Agreement at time of nomination.
- 13. I agree to abide by the rules and conditions of the Organising Committee and controlling Stewards and realise that contravention of these rules and conditions may mean DISQUALIFICATION from the event. The Stewards decision will be final.
- 14. I accept that notwithstanding any of the above, the Mailman Express Organising Committee reserves the right to vary these conditions as they may see fit.
